## FINES and PENALTIES SCHEDULE

### Introduction

If a transgression of any specific Conduct Rule is not covered in the schedule below, it does not mean that such transgression does not carry a fine or penalty. The Exco is always at liberty to issue an offender with a fine or penalty for deliberately and/or repeatedly breaking any of the Complex's Conduct Rules and Regulations. Remember, not knowing what is in the HOA's Constitution and/or the Conduct Rules and Regulations can never be used as an excuse for not complying with them.

Please refer to the HOA's Rules and Regulations, sub-rules 6.2 to 6.3 dealing with the administration of fines/penalties by the Exco.
